

RATE SCHEDULE

Effective January 1, 2017 *(Rates subject to change)*

PERMANENT MOORAGE

20', 24', 28' slips.....	\$ 7.50 per foot
32', 36' slips.....	\$ 8.45 per foot
40', 42', 44' slips.....	\$ 8.85 per foot
50' slips.....	\$ 9.15 per foot
>50' slips.....	\$ 9.55 per foot

- Monthly moorage fee is based on overall slip length
- Vessel overhang is not permissible
- **Leasehold tax of 12.84% included in rates**

GUEST MOORAGE

Reservations are available with a \$5.00 non-refundable fee & the first night's guest moorage paid in advance of dates reserved by calling 360.528.8049

- **Swantown Marina** minimum rate of \$20.00 per night for vessels 20 feet & under; \$.80 per foot additional for vessels 21 feet & over
 - Shore power is included in the rate
 - Guest moorage is limited to 29 days in a 12-month period
- **Port Plaza** minimum rate of \$10.00 per night for vessels 20 feet & under; \$.40 per foot additional for vessels 21 feet & over
 - Guest moorage is limited to 29 days in a 12-month period

DRY STORAGE

- Monthly rate.....\$80.00
- **Leasehold tax of 12.84% included in rate.**

MINI STORAGE

- Monthly rate.....\$85.00
- **Leasehold tax of 12.84% included in rate.**

CANOE/KAYAK STORAGE

- Monthly rate.....\$20.00
- **Leasehold tax of 12.84% included in rate.**

SHORE POWER

- Metered slips: \$6.00 plus kWh usage
- Non-metered slips: \$25.00 per month or \$3.00 per day
 - **Leasehold tax of 12.84% included in rate.**

PUBLIC LAUNCH RAMP

- Individual rate.....\$5.00
- Commercial rate.....\$50.00
- Annual pass.....\$50.00

LIVEBOARD

- Monthly rate.....\$75.00 *(or based on vessel size)*
- **Leasehold tax of 12.84% included in rate.**

PARKING.....\$4.00 per day

GENERAL LABOR.....\$65.00 per hour

HAUL-OUT & LAUNCH

ONE-WAY HAUL/LAUNCH

Up to 32'	33'-39'	40'-49'	50'-59'	60' +
\$5.45 per foot	\$5.95 per foot	\$6.80 per foot	\$7.55 per foot	\$8.30 per foot

- Up to one half hour sling time included in rate
- Additional sling time \$200.00 per hour

CRANE/FORKLIFT RATES

- Forklift with operator..... \$100.00 per hour (1/2 hour minimum)
- Crane with operator..... \$200.00 per hour (1/2 hour minimum)

PRESSURE WASH \$3.00 per foot

- An additional charge will apply for excessive growth removal or special bottom preparation

ENVIRONMENTAL FEE (N.P.D.E.S.) \$70.00

- Applies to all pressure washed vessels

BOATYARD STORAGE

Leasehold tax of 12.84% applicable on vessels and masts stored for 30 days or more

DAILY LAY-TIME

- First Seven Days \$0.75 per foot per day
- Additional Days \$1.00 per foot per day
- Lay-time charge not applicable to day in & day out

LONG-TERM STORAGE \$7.75 per foot per month

- Limited storage space available October 1- February 28, or otherwise based upon availability and management approval only
- Long term storage application must be signed and submitted prior to vessel haul-out
- Current storage information and applications are available online
- Leasehold tax of 12.84% included in rate
